Mission man dies after testing positive for COVID-19

A Mission man in his 50s with underlying medical conditions became Hidalgo County's eighth fatality after testing positive for COVID-19, Hidalgo County Judge Richard F. Cortez said Saturday. In addition to Saturday's fatality, ten more people tested positive for the virus, bringing the total number of known positive cases to 387.

"Another tragedy has visited us in Hidalgo County in the form of this deadly disease," Judge Cortez said of the death. "My condolences go out to this man's family and friends. I hope it serves as a reminder to us to take the necessary precautions to protect ourselves, including avoiding crowds."
