### Eleven more people in Hidalgo County test positive for COVID-19

With more than 30 people released from isolation today, another 11 people tested positive for COVID-19 bringing the total number of known cases of the virus to 548, County Judge Richard F. Cortez said Thursday.

"The recovery rate from COVID-19 continues to increase as more residents are released from isolation," Judge Cortez said. "I strongly urge residents to maintain good hygiene, wear face coverings as much as possible and practice social distancing while they are out in public."

Seventeen people are now hospitalized with complications from the virus; three of those cases are being treated in intensive care units. Thirty-one people were released from isolation meaning that they have been symptom free for 10 days, including three days without a fever. There are currently 195 active cases.
