### Twelve more people in Hidalgo County test positive for COVID-19

"As we continue an aggressive round of testing with the help of the State, we are seeing more infections," Judge Cortez said. "This disease has not gone away and we need to continue to be diligent about keeping ourselves safe. Despite the temptation to get out, please think about the possible consequences."

Twenty people are now hospitalized with complications from the virus; three of those cases are being treated in intensive care units. Three people were released from isolation meaning that they have been symptom free for 10 days, including three days without a fever. There are currently 204 active cases.
