15 more people test positive for COVID-19 in Hidalgo County

Over the weekend, the total number of known COVID-19 positive cases increased by fifteen, County Judge Richard F. Cortez said Sunday. That brings the total number of known cases in the county to 575.

Twenty people have been hospitalized with complications from the virus; 3 of those cases are being treated in intensive care units. Since no one was released from isolation over the weekend, there remains 219 active cases.
