Forty-five more people test positive for COVID-19 in Hidalgo County

Cortez said Thursday. That brings the total number of known cases in the county to 679 people.

"We have been saying for days that we knew an increase in positive cases was coming," Judge Cortez said. "When you test more people, you will find more people who are infected. Today's numbers are a reflection of the growing availability of testing locally, but also a grim reminder that this virus is still out there and can still infect us. As Governor Greg Abbott continues to loosen restrictions on our activities, we strongly urge caution around crowds."

In addition to private testing, the University of Texas Rio Grande Valley and the State of Texas have greatly expanded the availability of testing in Hidalgo County. Nearly 22,500 tests have now been administered in Hidalgo County. There are currently 1,400 roughly tests in which the results are pending and, in some cases, have been pending for weeks.

Because of more aggressive testing throughout Texas, there has been a delay in getting results so the large numbers of new positive cases often reflects several days worth of testing and does not necessarily reflect any rapid increase in the rate of infection.
