COVID-19 takes the life of one more person in Hidalgo County; another 402 test positive for the virus

EDINBURG – Over the course of the weekend one more person died from complications of COVID-19 as Hidalgo County Health officials report 402 new positive cases of the virus, Hidalgo County Judge Richard F. Cortez said Sunday. The total number of known positive cases has now surpassed the 3,000-mark with a total of 3,294 known cases.

The death involved a Weslaco man in his 30's with underlying medical conditions. The total number of people who have died after testing positive for COVID-19 is 32.

"I am very distraught with today's rising numbers and, in particular, with the report of another death," said Judge Cortez. "My condolences go out to this man's friends and family. Our rise in numbers has become a problem and I've taken action trying to slow infection rates by limiting mass and social gatherings, and by requiring facial coverings inside of covered spaces and buildings. Ultimately, however, we must protect ourselves."

There are currently 244 people who have been hospitalized with complications from the virus; 19 of those cases are being treated in intensive care units. There were 129 people released from isolation over the weekend meaning that they have been symptom-free for 10 days, including three days without a fever. There are currently 2,190 net active cases and 2,829 test results are pending.
