# 31 more people die of COVID-19 complications; 396 test positive

**EDINBURG** – Hidalgo County sees its deadliest day yet as 31 more people have died of complications related to COVID-19, bringing the total number of fatalities to 183, Hidalgo County Judge Richard F. Cortez said Tuesday. Health officials also reported 396 new cases of COVID-19 bringing the total number of known cases to 8,593.

"I am deeply saddened today knowing that we continue to lose more and more of our neighbors to this terrible virus," said Judge Cortez. "The continued rise in fatalities and total positive cases is a grim reminder that this disease does not discriminate, and that we must all do our part if we are to overcome it."

There are currently 834 people who have been hospitalized with complications from the virus; 210 of those cases are being treated in intensive care units. No one was released from isolation today. Currently, there are 5,031 net active cases and 1,087 test results pending.
