Twenty-seven people die with COVID-19 complications; 451 people test positive

EDINBURG – As we surpass the 70,000 mark on COVID-19 tests administered, 27 residents have died due to complications related to the virus, Hidalgo County Judge Richard F. Cortez said Friday. Today, 451 people tested positive bringing the total number of positive cases to 10,943.

"I send my condolences to these 27 families for the loss of their loved one," said Cortez. "Our medical experts tell us the best way to stop the spread is to wear a mask, use proper hygiene, keep 6 feet apart from others, and avoid any social gatherings of 10 people or more."

There are 5,780 net active cases and 505 people were released from isolation on Friday meaning that they have been symptom-free for 10 days, including three days without a fever. There are currently 982 people hospitalized with complications from the virus; 304 of those cases are being treated in intensive care units.

There will not be a report on Saturday. The next report will be released on Sunday, July 19, 2020.
