Thirty-three people die with COVID-19 complications; 650 people test positive

EDINBURG – As the death toll reaches 400, 33 residents have died today due to complications related to COVID-19, Hidalgo County Judge Richard F. Cortez said Wednesday. Another 650 have tested positive for the virus bringing the total number of positive cases to 13,776.

"I am truly saddened by the passing of all 33 of our neighbors. My deepest sympathies and prayers go out to the friends and families who lost their loved ones," said Judge Cortez. "Our Shelter at Home order goes into effect tonight, I encourage you all to do your part in saving lives by abiding by the curfew, limiting your outings to only essential needs, avoiding any mass gatherings and continuing to use facial coverings while out in public."

There are 7,675 net active cases and 228 people were released from isolation on Wednesday meaning that they have been symptom-free for 10 days, including three days without a fever. There are currently 1,080 people hospitalized with complications from the virus; 257of those cases are being treated in intensive care units.
