# COVID-19 claims the lives of 25 more people in Hidalgo County; 528 more test positive for the virus

**EDINBURG** – It was another tragic day in which 25 residents have died after testing positive for COVID-19. Positive case numbers also continue to rise as 528 more people learned they tested positive bringing the total number of known positive cases to 22,826, Hidalgo County Judge Richard F. Cortez said Tuesday.

"Our collective hearts are heavy with sympathy. My most heartfelt condolences to the friends and family of the 25 members of our community that have lost their battle against this terrible virus," Judge Cortez said. "We need to take action now and do what's in the best interest of our community. If you decide to engage in public activities, continue to protect yourself by practicing everyday preventive actions."

As of today, 444 people have been hospitalized with complications from the disease with 185 of those in intensive care units.

There are currently 4,893 net active cases and 450 people were released from isolation on Tuesday, meaning that they have been symptom-free for 10 days, including three days without a fever.
