Hidalgo County sees an additional 23 COVID-19 related fatalities and 480 new positive cases

EDINBURG — Twenty-three more people have died from complications related to COVID-19 and another 480 people have tested positive for the virus. This brings the total number of COVID related deaths in Hidalgo County to 1,071 and the total number of known positive cases to 23,993.

"These numbers, particularly of those who died, should bring pain to us all as a community. These are our family, friends and neighbors who are falling victim to this terrible disease. I send them all my prayers and I send those who knew them my condolences," Hidalgo County Judge Richard F. Cortez said Friday. "To everyone else, I send my plea to protect yourselves by staying home unless absolutely necessary, to continue using face coverings and keeping your distance from others when you do venture out. These common-sense measures can save your life and stop the pain of our community."

Friday saw a total of 414 people in hospitals, down slightly from the 445 people in area hospitals the day before; a total of 164 of those hospitalized were in intensive care units. A total of 786 people were released from isolation Friday contributing to the total of 18,504 people who have been released in Hidalgo County since the start of the pandemic. There will be no update on Saturday. The next update will be Sunday.
