# Nine people die due to COVID-19 complications; 655 tested positive for the virus

**EDINBURG** – Nine residents have died today due to complications related to COVID-19 and 655 people tested positive for the virus. The total number of positive cases is 26,606.

"I send my deep sympathy to the families of the nine residents and urge all Hidalgo County residents to continue following the guidelines to protect each other," County Judge Richard F. Cortez said. "People at increased risk of severe illness from COVID-19, and those who live with them, should consider their level of risk before deciding to go out and ensure they are taking steps to protect themselves. Consider avoiding activities where taking protective measures may be difficult, such as activities where social distancing can't be maintained."

Judge Cortez acknowledged that the number of positive cases has risen, but noted that much of this rise in numbers can be attributed to the Department of Health and Human Services clearing up a backlog in testing results that has arisen both locally and statewide.

There are currently 2,637 net active cases and 565 people were released from isolation on Wednesday, meaning that they have been symptom-free for 10 days, including three days without a fever.
