Eighteen die from COVID-19 complications; 329 others test positive for the virus

EDINBURG – Eighteen residents have died due to complications related to COVID-19, while 329 learned they have tested positive for the virus.

"My prayers and condolences go out to the families and friends of the 18 individuals," said Hidalgo County Judge Richard F. Cortez. "To those currently battling this disease and who are at home, I urge you to remain quarantined so that you may not infect a loved one or anyone in our community."

The latest case totals bring the count of people in the county who have died from this disease to 1,488. The total number of people who have knowingly contracted the disease in Hidalgo County now stands at 30,375.
