Twenty-two more people die from complications of COVID-19; 202 more test positive in Hidalgo County

EDINBURG – Another 22 deaths from complications of COVID-19 were reported Friday while 202 new positive cases were logged, Hidalgo County Judge Richard F. Cortez said Friday.

"The death and infection numbers continue to rise," Judge Cortez said. "We should all be concerned and we should all pray for the families and friends of those who have died."

The latest case totals bring the count of people in the county who have died from this disease to 1,510. The total number of people who have knowingly contracted the disease in Hidalgo County now stands at 30,577.
