Nineteen more deaths related to COVID-19 reported in Hidalgo County along with 130 new positive cases

EDINBURG - Officials with the Hidalgo County Health and Human Services Department reported 19 more deaths related to COVID-19 and 130 new known positive cases, Hidalgo County Judge Richard F. Cortez said Thursday.

"These deaths continue to concern me and should concern everyone else in the county," Judge Cortez said. "I extend my condolences to the family and friends of those who have died from this terrible disease."
