# Five more in Hidalgo County test positive for COVID-19 on Sunday

Hidalgo County health officials reported five more people tested positive for COVID-19, Hidalgo County Judge Richard F. Cortez said Sunday. This marks the second day in a row in which a handful or less have tested positive for this form of coronavirus.

"Hopefully, this trend continues. But I am also hopeful that we will begin seeing a similar drop in the number of people who need hospitalization after testing positive," Judge Cortez said. That number remained steady on Sunday with 21 people in area hospitals; five of them in intensive care units.
