Twenty-six more people in Hidalgo County test positive for COVID-19

EDINBURG – With nearly 4,000 tests awaiting results, 26 more people learned that they have tested positive for COVID-19 bringing the total number of known cases of the virus to 610, County Judge Richard F. Cortez said Tuesday.

Part of the backlog of testing results comes from the aggressive testing being provided by state officials who are meeting a mandate by Governor Greg Abbott to test 2 percent of the state's population and 100 percent of all nursing home residents and their staffs.

Twenty-seven people remain hospitalized with complications from the disease with three of those in intensive care units.

"We expect to continue to see an upward trend in the number of positive cases as testing becomes more widely available," said Judge Cortez. "It is yet another reminder that the danger of infection remains and precautions to avoid infection should still be followed."

Sixteen people were released from isolation so there are a total of 228 active cases. A total of 16,591 tests have now been administered in the county — 750 of those have been public tests and 15,841 have been private laboratories/other conducting the tests. There are a total of 3,900 pending test results.
