Forty-five more people test positive for COVID-19 in Hidalgo County

EDINBURG – Forty-five more people in Hidalgo County have learned that they tested positive for the COVID-19 virus, bringing the total number of known cases in the county to 804, Hidalgo County Judge Richard F. Cortez said Tuesday.

The increase in positive cases comes roughly two weeks after the Memorial Day weekend, which is typically the time period when new cases develop. But it also comes amid an increase in the availability of tests in Hidalgo County and experts have always said that more testing will result in more positive results. The number of tests conducted in the county is now 24,000. That puts the rate of positive infection at just above 3.35 percent. The World Health Organization said an ideal positive rate is 10 percent or below.

“While there may be different theories as to what is causing these numbers to rise, no one is debating that this disease is still here and the risk of infection is still genuine,” Judge Cortez said. “The community must act cautiously and must act responsibly. The best way to do that is to avoid crowds and continue to practice good hygiene.”

There are currently 1,263 tests pending and a total of 343 active cases. Forty-four people have been hospitalized with complications from the virus; four of those cases are being treated in intensive care units.
