### COVID-19 takes the lives of 3 more residents in Hidalgo County

**EDINBURG** – Three more people with underlying medical conditions, all residents of Pharr, died Monday from COVID-19 complications, Hidalgo County Judge Richard F. Cortez said. There are now 15 people who have died because of this destructive COVID-19 virus since they tested positive in Hidalgo County.

All three cases were unrelated. The youngest was a woman in her 40s. The two other women were in their 80s. Both of the older women were part of a cluster meaning they likely contracted the virus from someone they knew.

"This is an especially tragic day," Judge Cortez said. "Not only because this virus contributed to the deaths of three of our neighbors, but also because the two older and more vulnerable victims probably knew the person who infected them. That's the danger of this virus. It can be contracted by someone who is both younger and healthier, then transmitted to someone who is older and more vulnerable. I extend my sincere condolences to these families that have lost loved ones."

The deaths come on a day when 62 more people learned that they have tested positive for the disease bringing the known number of cases in Hidalgo County to 1,112. Sixty-nine have been hospitalized with complications from the virus; nine of those cases are being treated in intensive care units. 12 people were released from isolation on Monday meaning that they have been symptom free for 10 days, including three days without a fever. There are currently 571 net active cases and 1,529 test results are pending.
