Two more deaths, 92 more positive tests for COVID-19 in Hidalgo County

EDINBURG – Two more people have died from complications of COVID-19 on a day that 92 others learned they have tested positive for the virus, Hidalgo County Judge Richard F. Cortez said Wednesday. This brings the total number of COVID-19 related fatalities in the county to 19 people and the total number of known positive cases to 1,347.

"These numbers are dismaying," Judge Cortez said. "Losing two more people from our community shows how dangerous this disease can be. My prayers are with the family and friends of these two people."

The deaths involved a man in his 30s from Weslaco and a man in his 50s from Mission. Both cases involved underlying medical conditions.

A total of 84 people have been hospitalized with complications from the virus; ten of those cases are being treated in intensive care units. Sixteen more people were released from isolation on Wednesday meaning that they have been symptom-free for 10 days, including three days without a fever. There are currently 733 net active cases and 999 test results are pending out of a total 28,469 tests that have been administered.
