Three more people died from complications related to COVID-19; 248 people test positive for the virus

EDINBURG – Three more people have died as a result of complications related to COVID-19, Hidalgo County Judge Richard F. Cortez said Monday. This comes as 248 people learned they tested positive for the virus bringing the total number of known positive cases is now 3,542.

The deaths involved a Male in his 30s from Weslaco, a Male in his 70s from McAllen, and a Female in her 80s from McAllen. They all had underlying medical conditions.

"My deepest condolences to the families and friends of these three people. We want you to know that Hidalgo County mourns with you," said Judge Cortez. "Today, I met with hospital administrators from across the county and their message was unified and clear: we as a community are in control. If we take the necessary precautions such as wearing facial coverings, avoiding mass gatherings and maintaining social distancing then we can help save lives."

There are currently 2,412 net active cases and 3,879 test results are pending. There are 257 people hospitalized with complications from the virus; 18 of those cases are being treated in intensive care units. Twenty-three people were released from isolation on Monday meaning that they have been symptom-free for 10 days, including three days without a fever.
