COVID-19 claims the lives of 64 people; 339 tested positive for the virus

EDINBURG – Hidalgo County Health officials reported a single day high record of 64 deaths due to complications related to COVID-19 bringing the total number of fatalities to 531, said Hidalgo County Judge Richard F. Cortez Tuesday. Another 339 tested positive for the virus which brings the total number of known positive cases to 16,088.

The high death toll numbers reflect the delayed reporting of data from Sunday and Monday. Data reported by hospitals to county officials was delayed as a result of connectivity issues caused by Hurricane Hanna.

"I am saddened by the passing of our Hidalgo County residents. My prayers and thoughts go out to their families," Judge Cortez said. "I continue to ask for you to take the necessary precautions for the safety of yourself and your loved ones."

There are 7,450 net active cases and 373 people were released from isolation on Tuesday meaning that they have been symptom-free for 10 days, including three days without a fever.

We are also reporting the information for positive cases for Monday, July 27, 2020.
