Sixteen more deaths related to COVID-19 reported in Hidalgo County along with 174 new positive cases

EDINBURG – Officials with the Hidalgo County Health and Human Services Department reported 16 more deaths related to COVID-19 and 174 new known positive cases, Hidalgo County Judge Richard F. Cortez said Tuesday.

"The deaths and those contracting this disease continue to add up," Judge Cortez said. "I send my sincere condolences to the family and friends of those who died and I pray for a quick recovery for those who are sick."
