# Five more deaths and 171 new cases related to COVID-19 reported in Hidalgo County

**EDINBURG** – Five more deaths and 171 new positive cases related to COVID-19 were reported Thursday by officials with the Hidalgo County Health and Human Services Department, Hidalgo County Judge Richard F. Cortez said Friday. The result is a total of 1,919 recorded deaths related to the outbreak of this disease and 34,970 known positive cases.

"Five deaths from this disease are five too many," Judge Cortez said. "I send my condolences to the family and friends of those who have died."
