Health officials report three more deaths related to COVID-19 reported in Hidalgo County and 160 new positive cases

EDINBURG - Officials with the Hidalgo County Health and Human Services Department reported three more deaths related to COVID-19 on Friday and 160 new known positive cases, Hidalgo County Judge Richard F. Cortez said Friday.

"Tomorrow is Election Day and we urge caution as people head out to cast their ballots, but we also offer assurance that our elections division is doing all it can to keep voters and election workers safe," Judge Cortez said. "To the family and friends of those who have died, I offer my sincere condolences."
