Health officials report six more deaths related to COVID-19 in Hidalgo County and 130 new positive cases

EDINBURG - Officials with the Hidalgo County Health and Human Services Department reported six more deaths related to COVID-19 on Tuesday and 130 new known positive cases, Hidalgo County Judge Richard F. Cortez said Tuesday.

"Every day, we continue to lose more of our relatives and neighbors," Judge Cortez said. "I offer my condolences to those family and friends of the people who have died from this terrible disease."
