Health officials report two more deaths related to COVID-19 in Hidalgo County and 216 new positive cases

EDINBURG – Two more Hidalgo County residents died from COVID-19 related causes and 216 more people tested positive, officials with the Hidalgo County Health and Human Services Department reported Wednesday.

"Number of those who have died is thankfully, lower, compared to previous days but there are still too many." Hidalgo County Richard F. Cortez said. "I extend my prayers and my condolences to the family and friends of these two people."
