The 28 cases reported today raises the total number of COVID-19 cases to 53,791 in Cameron County. There have also been an additional 22 individuals who have recovered, raising the total number of recovered individuals to 50,664.

Cameron County Public Health has received notification of four (4) additional COVID-19 related deaths of Cameron County residents. Of the reported deaths, three were unvaccinated. This raises the total of number of COVID-19 deaths in Cameron County to 2,000.

As of today, 73.60% of the population 5 years and older in Cameron County is fully vaccinated and 87.18% has received at least one dose. In addition, 87.92% of the population 65 years and older in Cameron County is fully vaccinated and 96.54% has received at least one dose.
