The Special Supplemental Nutrition Program for Women, Infants and Children, popularly known as WIC, is a nutrition program for pregnant, breastfeeding or postpartum women and families with children younger than 5 years of age.

As a WIC participant, you will enjoy the benefits of:

- Personalized nutrition and breastfeeding counseling
- Healthy foods
- Peer support groups
- Referrals to other services

Eligibility criteria for participation in WIC:

- Meet categorical criteria
- Meet requirements for identification and residence (Live in Texas)
- Not exceed the income standards
- Have one or more nutritional risk

U.S. Citizenship is not a requirement for eligibility.

WIC benefits are not subject to Public Charge.

WIC is open to many incomes and families. If you are on Medicaid, TANF, or SNAP, you meet income eligibility guidelines for WIC or you may still qualify for WIC by meeting the income guidelines for your household.
