The 27 cases reported today raises the total number of COVID-19 cases to 53,244 in Cameron County. There have also been an additional 31 individuals who have recovered, raising the total number of recovered individuals to 48,995.

Cameron County Public Health has received notification of five (5) additional COVID-19 related deaths of Cameron County residents. Of these reported deaths, four were unvaccinated. This raises the total of number of COVID-19 deaths in Cameron County to 1,968.

As of today, 82.57% of the population 12 years and older in Cameron County is fully vaccinated and 95.30% has received at least one dose. In addition, 86.61% of the population 65 years and older in Cameron County is fully vaccinated and 94.37% has received at least one dose.
