The 118 cases reported today raises the total number of COVID-19 cases to 53,465 in Cameron County. There have also been an additional 78 individuals who have recovered, raising the total number of recovered individuals to 49,168.

Cameron County Public Health has received notification of three (3) additional COVID-19 related deaths of Cameron County residents. Of these deaths, two were unvaccinated. This raises the total of number of COVID-19 deaths in Cameron County to 1,975.
