Cameron County continues the vaccination efforts within our communities. As of today, 57.73% of the population 12 years and older in Cameron County is fully vaccinated and 71.16% has received at least one dose. In addition, 78.17% of the population 65 years and older in Cameron County is fully vaccinated and 87.19% has received at least one dose.
