The 38 cases reported today raises the total number of COVID-19 cases to 54,096 in Cameron County. There have also been an additional 22 individuals who have recovered, raising the total number of recovered individuals to 50,964.

Cameron County Public Health has received notification of one (1) additional COVID-19 related death of a Cameron County resident. The individual was unvaccinated. This raises the total of number of COVID-19 deaths in Cameron County to 2,011.

In addition, 88.78% of the population 65 years and older in Cameron County is fully vaccinated and 99.18% has received at least one dose.
