The 20 cases reported today raises the total number of COVID-19 cases to 53,631 in Cameron County. There have also been an additional 166 individuals who have recovered, raising the total number of recovered individuals to 49,884.

Cameron County Public Health has received notification of one (1) additional COVID-19 related death of a Cameron County resident. The reported death was not vaccinated. This raises the total of number of COVID-19 deaths in Cameron County to 1,987.

Cameron County continues the vaccination efforts within our communities. As of today, 72.97% of the population 5 years and older in Cameron County is fully vaccinated and 84.80% has received at least one dose. In addition, 87.37% of the population 65 years and older in Cameron County is fully vaccinated and 95.70% has received at least one dose.
