The 37 cases reported today raises the total number of COVID-19 cases to 53,861 in Cameron County. There have also been an additional 27 individuals who have recovered, raising the total number of recovered individuals to 50,751.

Cameron County Public Health has received notification of three (3) additional COVID-19 related deaths of Cameron County residents. Of the reported deaths, two were unvaccinated. This raises the total of number of COVID-19 deaths in Cameron County to 2,005.
