The 159 cases reported today raises the total number of COVID-19 cases to 45,227 in Cameron County. There have also been an additional 235 individuals who have recovered, raising the total number of recovered individuals to 41,313.

Cameron County Public Health has received notification of four additional COVID-19 related deaths of Cameron County residents. This raises the total of number of COVID-19 deaths in Cameron County to 1,719.
