

MOBILE VIDEO TAPES d/b/a KRGV-TV5, and d/b/a KRGV-DT, its subsidiaries and affiliated companies (together, the "Company"), will conduct the Contest substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. **Description of Contest/Participation.** 1 high school band will be the named KRGV Band of the Week each week for a total of 12 weeks. Winner will be chosen based on most votes received on the KRGV Sports Twitter. Band of the Week will receive a "Band of the Week" banner to display at football games.
- 2. **Dates of Contest:** The Contest will begin on Monday, August 30, 2021 and run until Wednesday, November 17, 2021.
 - A. NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING. Void where prohibited. Odds of winning depend upon the number of entrants.
- 3. **How to Enter:** Each week KRGV will choose three high school bands Across the RGV and post a poll on KRGV Sports Twitter page where participants can vote for the band of their choice. The poll will be posted on Monday at noon for the 12 weeks of football season. Participants have 24 hours to vote. The band with the most votes becomes the KRGV Band of the Week.
- 4. **Winning the Contest.** The winner will be based on the band that receives the most votes. Twitter polls are based on percentages, the winner with the highest percentage (based on number of people that vote) will be our KRGV Band of the Week. The Band of the Week will be announced every Wednesday on CHANNEL 5 NEWS at 6 and receive "Band of the Week" banner to display at football games.
- 5. Eligibility and Limitations. Participants and winners must be U.S. residents at least 18 years old (as of December 30, 2020) as determined by the Company, and must reside in Hidalgo, Cameron, Willacy or Starr County, Texas. Employees of the Company, the Contest's participating sponsors and their advertising agencies, members of the immediate family of any such persons are not eligible to participate and win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.
- 6. **Delivery Disclaimer.** The Company is not responsible for mechanical, technical, electronic, communications, telephone, computer, hardware or software errors, malfunctions or failures of any kind, include: failed, incomplete, garbled or delayed transmission of online entries, traffic congestion on telephone lines, the Internet or at any website or lost or unavailable network connections which may limit an online
