The 41 cases reported today raises the total number of COVID-19 cases to 52,918 in Cameron County. There have also been an additional 46 individuals who have recovered, raising the total number of recovered individuals to 48,615.

Cameron County Public Health has received notification of two (2) additional COVID-19 related deaths of Cameron County residents. Of these deaths, one was unvaccinated. This raises the total of number of COVID-19 deaths in Cameron County to 1,954.
