

Statement of Work – Lodging for Port
Detainees - 70B03C19Q00000102

U.S. Customs and Border Protection, Brownsville Port of
Entry Laredo Field Office

BACKGROUND:

U.S. Customs and Border Protection (CBP), Office of Field Operations (OFO) Brownsville Port of Entry is responsible for the temporary and/or overnight housing of persons detained by U.S. Customs and Border Protection Officers at the Brownsville International Port of Entry.

SCOPE:

Brownsville Port of Entry is required, to provide adequate detention for those individuals who are arrested and/or detained and furthermore arrested for violations of Federal law by the Brownsville Criminal Enforcement Unit. The contracted detention facility shall be responsible for providing housing accommodations to those arrested and/or detained individuals up until the detainee is physically returned to the custody of CBP for arraignment before a U.S. Federal Magistrate Judge.

The detainees must be kept in the custody of an approved county or state jail facility meeting the requirements of the U.S. Marshal's Service. All detainees processed under this contract will be at least 18 years of age or older.

SPECIFIC VENDOR TASKS:

The contracted detention facility will be responsible for providing:

- A facility for the safe-keep and detention of each CBP detainee received. Estimated total of monthly beds is 30.
- Three (3) scheduled meals; morning 0600hrs, noon 1200hrs, and evening NLT 1900hrs.
- Immediate minor medical attention.
- Access to utility blankets and lavatory.
- Ongoing communication with CBP regarding any detainee concerns.
- Be located within a 30-mile commuting radius from the Brownsville Port of Entry.

The Contracted detention facility shall take custody of the detainees until such time as CBP or a government contracted transportation service accepts physical custody and transports the detainee to the determined destination. Once physical and secure custody is returned to CBP and/or the contracted transportation service, the contracted detention facility is presumed to be relieved of their arrestee/detainee custody responsibilities.

DELIVERABLES AND DELIVERY SCHEDULE:

CBP will coordinate with the contracted detention facility and request bed space using CBP Form I-201 prior to transport. The contracted detention facility shall be prepared to receive and retain said individuals 24 hours of the day, 7 days of the week with the exception of unexpected and/or emergencies. CBP will be responsible for ensuring the transportation of detainees/arrestees to and from the contracted detention facility. CBP Officers and/or CBP transportation contractor will provide transportation of detainees/arrestees to the facility. The contracted detention facility

shall permit CBP and/or CBP transportation contractor to bring a vehicle onto the facility property or sally port, if available, to off-load the detainees to the facility booking area. CBP and/or the CBP transportation contractor will provide adequate security during the transportation of the detainees, both of the loading and off-loading points.

GOVERNMENT FURNISHED EQUIPMENT AND INFORMATION:

- CBP will provide to the contracted detention facility a completed CBP Form I-203 Order to Detain or Release detailing the detainee/arrestee biographical information.
- CBP will provide the transportation of the detainees as outlined in the deliverables and delivery schedule section.
- CBP will provide to the contracted facility a case of disposable survival blankets for the exclusive use of CBP detainees/arrestees held at the facility who overnight.
- CBP will also provide the contracted detention facility twenty (20) new utility blankets for the exclusive use of CBP detainees/arrestees held at the facility on weekends. The contracted detention facility will assume the responsibility of laundering the utility blankets.

V No additional equipment will be provided by CBP to the contracted detention facility.

PERIOD OF PERFORMANCE:

The period of performance will be for a period of 60 months from date of award with a possible extension of up to 6 months.

SECURITY:

The work and duties outlined on this contract will be provided by State of Texas Licensed Peace Officers sworn to uphold the law.
