

MOBILE VIDEO TAPES d/b/a KRGV-TV5, and d/b/a KRGV-DT, its subsidiaries and affiliated companies (together, the "Company"), will conduct the Contest substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. **Description of Contest/Participation.** 1 winner will win a trip for four to Cancun during CHANNEL 5 NEWS THIS MORNING.
- 2. Dates of Contest: The Contest will begin on Monday, July 21st and run until Thursday, July 31st, 2025.
 - A. NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING. Void where prohibited. Odds of winning depend upon the number of entrants.
- 3. How to Enter: Watch CHANNEL 5 NEWS THIS from Monday, July 21st through Thursday, July 31st, there will be a QR Code on screen to register and a code word. We will draw the winner LIVE during the newscast on 8/1.
- 4. Winning the Contest. The winner will be selected via a drawing. Before proceeding to naming the winner, all contest rules must be verified. If person is not in compliant with the rules, another name will be chosen. The winner will be announced on CHANNEL 5 NEWS THIS MORNING on 08/1.
