

MOBILE VIDEO TAPES d/b/a KRGV-TV5, and d/b/a KRGV-DT, its subsidiaries and affiliated companies (together, the "Company"), will conduct the Contest substantially as described in these rules, and by participating, each entrant agrees as follows:

- Description of Contest/Participation. 1 winner will win a family 4 pack to Hot Wheels each day for 5 days during CHANNEL 5 NEWS THIS MORNING (total of 5 family packs will be awarded). Hot Wheels will take place at the Bert Ogden Arena from Saturday February 25, 2023 – Sunday February 26, 2023.
- 2. Dates of Contest: The Contest will begin on Monday, February 20, 2023 and will run until Friday, February 24, 2023.

- 4. **Winning the Contest.** The winner will be selected based on the first person to call and say correct code word. Before proceeding to naming the winner, all contest rules must be verified. If person is not in compliant with the rules, another name will be drawn.. The winner will be announced on CHANNEL 5 NEWS THIS MORNING.
