The 294 cases reported today raises the total number of COVID-19 cases to 50,916 in Cameron County. There have also been an additional 302 individuals who have recovered, raising the total number of recovered individuals to 46,601.

Cameron County Public Health has received notification of sixteen (16) additional COVID-19 related deaths of Cameron County residents. Of these deaths, 15 out of 16 were not fully vaccinated, and the individual who was fully vaccinated had multiple underlying conditions. This raises the total number of COVID-19 deaths in Cameron County to 1.840.
