The 48 cases reported today raises the total number of COVID-19 cases to 42,629 in Cameron County. There have also been an additional 87 individuals who have recovered, raising the total number of recovered individuals to 40,110.

Cameron County Public Health has received notification of one (1) additional COVID-19 related death of a Cameron County resident. This raises the total number of COVID-19 deaths in Cameron County to 1,694.
