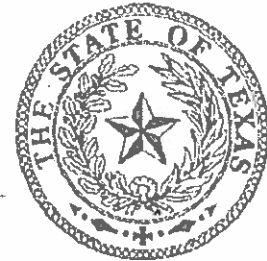

*In the Name and by Authority of the State of Texas:*

Before me, the undersigned authority, on this day personally appeared the undersigned Affiant, who after being by me duly sworn, on oath deposes and says that he has good reason to believe and does believe and charge that:

**COUNT I**  
**ASSAULT CAUSES BODILY INJURY**

Jose Francisco Perez Jr, on or about the 1st day of June, A.D. 2024, and before the making and filing of this complaint, in the County of Starr, State of Texas, did then and there intentionally, knowingly, and recklessly cause bodily injury to Roxana Garza by pulling her hair and then pushing her causing her to fall and hit a table, causing her to get a laceration behind her left ear.

**PROBABLE CAUSE**

On his oath, Affiant further deposes and says that he has bases his belief of the foregoing upon Affiant's personal investigation of the offense.

On Saturday, June 01, 2024, I, Escobares Police Department Officer Ricardo Flores #334, began my investigation of a domestic disturbance that occurred in [REDACTED] [REDACTED] Roma, Texas 78584 that was referred to the Escobares Police Department by

the Starr County Sheriff's Office (SCSO case number 2024-01396). I reviewed the body camera recording from Deputy Ryan Garcia #147 from when he responded to the call for service. In his investigation, Deputy Garcia was advised that Jose Francisco Perez Jr, a Commissioner for Starr County, had assaulted the complainant, Roxana Garza and her daughter. Roxana stated that Jose had grabbed her by the hair and pulled her into the residence. Roxana stated she acquired an injury to the back of her head and it was caused when Jose assaulted her. An injury was observed by Deputy Garcia behind Roxana's left ear and he described it as a deep laceration. Pictures were taken by Deputy Garcia of the injury.

I reviewed the pictures of the injuries taken that day by Deputy Garcia, and observed a cut with blood behind the left ear. I also observed the ear itself appeared bruised/scrapped and redness below the cut.

On June 1, 2024, at approximately 2:10 PM, Jose Francisco Perez Jr (D.O.B. [REDACTED] 1974) came to the Escobares Police Department to speak with officers regarding the incident from this morning. The interview was recorded using a work phone and Jose was read his Miranda Rights, which he waived, signed the document saying so, and decided to speak to me. Jose admitted to grabbing Roxana by the hair when he "tried to put her to go inside" the residence.

On June 1, 2024, at 2:56 PM, I interviewed the complainant, Roxana Garza (D.O.B. [REDACTED] 1991) at her residence on [REDACTED] Roma Starr County, Texas 78584.

Roxana stated that she was drinking with her sister-in-law across the street from her home when her partner/boyfriend, Jose Francisco Perez Jr (D.O.B. [REDACTED] 1974), arrived and parked at her residence at [REDACTED]. She met with Jose to see what he wanted. They argued outside and Jose became physical. At one point Jose pushed her causing her to fall by the porch area outside of her residence. After she thought the altercation ended, they walked their separate ways. She suddenly felt her hair being pulled by Jose and she was dragged/pulled into her own residence. Once inside she just remembered being thrown and hitting herself. She hit herself with the brown table located in the living room, which is what caused her to get a cut behind her ear. She blacked out

for a moment and when she came to, Jose was holding her daughter back by the hoodie. She later noticed that she had a scratch mark on her left shoulder/collarbone area as well.

I observed Roxana to have swelling and purple coloration behind her ear where there was a cut approximately 1/2 inch long.

I reviewed the surveillance from "Camera 01" footage from [REDACTED]. The time stamp was an hour ahead of the correct time but the date was from 06/01/2024. At the date and time stamp of 06-01/2024 at 03:10:58, Jose can be seen walking away from Roxana as she walks up the porch and towards the south end of the porch. Jose then walks back at a fast pace towards Roxana. Jose can then be seen grabbing Roxana from the hair and pulling/forcing her into the residence. Roxana appeared to be trying to pull back and away from Jose.


I spoke to Briana Alvarez and Brenda Castillo who stated that they did not observe the altercation, but they did observe that Jose arrived at location and when he left, he and Roxana were fighting. Roxana had acquired injuries with the encounter with Jose.

On Tuesday, June 4, 2024 at approximately 12:00PM, [REDACTED] [REDACTED] was interviewed by Forensic Interviewer Cassandra Cruz at the Children's Advocacy Center of Hidalgo and Starr Counties located at 116 North Conway Avenue in Mission, Hidalgo County, Texas. During the interview, [REDACTED] stated she observed that Jose was grabbing her mother by the hair, and forced her into the residence. Jose then pushed her mother and caused her to fall and hit a brown table in the living room. This caused her mother to get a cut behind her ear.



In his investigation, Deputy Garcia was advised that Jose Francisco Perez Jr, a Commissioner for Starr County, had assaulted the complainant, Roxana Garza and her daughter. Roxana stated that Jose had grabbed her by the hair and pulled her into the residence. Roxana stated that Jose had grabbed her daughter [REDACTED] [REDACTED] by the neck and hoodie. Roxana stated that she had to punch and starch Jose to make him let go of her daughter. Once [REDACTED] was let go of, [REDACTED] went to the neighbors and was able to contact 911. [REDACTED] had advised Deputy Garcia that Jose had choked her and pulled her by the hoodie.

On June 1, 2024, at 2:56 PM, I interviewed the complainant, Roxana Garza (D.O.B. [REDACTED] 991) at her residence on [REDACTED] Roma Starr County, Texas 78584. Roxana stated that after she was thrown by Jose and she lost consciousness, she instructed [REDACTED] to go with Briana and call the cops. Jose would not let her go, he kept pulling her back and pulling her back from the hoodie. [REDACTED] was crying hysterically. She then punched Jose in the face so he would let go of [REDACTED] began running back and forth the residence trying to get out.

I then proceeded to [REDACTED] in Roma, Starr County, Texas 78584, to speak to Briana and her mother, Brenda regarding the matter. When I spoke with Briana, she stated that [REDACTED] came running to her home and asking her to call 911. When they went over to see what was going on, she went up to [REDACTED] who was alone, and stated that Jose had grabbed and pulled her by the jacket to prevent her from leaving to ask for help.


On Tuesday, June 4, 2024 at approximately 12:00PM, [REDACTED] was interviewed by Forensic Interviewer Cassandra Cruz at the Children's Advocacy Center of Hidalgo and Starr Counties located at 116 North Conway Avenue in Mission, Hidalgo County, Texas. [REDACTED] stated that her mom asked her to go call someone for help, and that was when he pushed her mom which made her fall and get a cut behind her ear (she pointed towards the head behind the ear). This was caused by her mom hitting a brown table in the living room where she fell next to. He then began grabbing her [REDACTED] from the Buc-ee's brand hoodie and would not let her go. Her mother then punched him in the

face to make him let go off her. She was really scared and was shaking throughout the entire incident because she was scared of what he might have done to her.



Jose Francisco Perez Jr. on or about the 1st day of June, A.D. 2024, and before the making and filing of this complaint, in the County of Starr, State of Texas, did then and there knowingly prevent or interfere with the ability of Roxana Garza to place an emergency telephone call to a law enforcement agency.

**PROBABLE CAUSE**

On his oath, Affiant further deposes and says that he has bases his belief of the foregoing upon Affiant's personal investigation of the offense.

On Saturday, June 01, 2024, I, Escobares Police Department Officer Ricardo Flores #334, began my investigation of a domestic disturbance referred to the Escobares Police Department by the Starr County Sheriff's Office (SCSO case number 2024-01396).



I then reviewed the report from the Starr County Sheriff's Office that was provided. The report stated that Deputy Garcia was radio dispatched on Saturday, June 1, 2024 at approximately 2:15 AM to the address of [REDACTED], Roma, Texas 78584 in regards to a domestic. Deputy Garcia made contact with the complainant, later identified as Roxana Garza (D.O.B. [REDACTED] 1991), who stated that her partner, Jose Francisco Peres Jr "Kiko" (No date of birth documented) had assaulted her. The complainant had attempted to contact 911 using her Apple Watch, but was unable to do so because Jose had yanked the watch off of her wrist before she could make the call. Deputy Garcia mentioned that he observed bruising on the wrist of the complainant and took pictures. Deputy Garcia managed to find the Apple Watch belonging to the complainant on the ground and the band appeared to have been ripped.

I reviewed the body camera footage from Deputy Garcia provided for the case. I observe that Deputy Garcia was made aware by the complainant, Roxana, that she attempted to contact law enforcement using her Apple Watch. Jose did not allow her to do so by grabbing the watch and yanking it off her and throwing it. Deputy Garcia states he can see bruising on the complainant's wrist. Deputy Garcia searches for the watch and locates it near the front porch of [REDACTED]

When I reviewed the pictures Deputy Garcia took for the case, I observed an Apple Watch with a damaged band on the ground. I also observed the complainant's wrist to have bruising and her skin to be scrapped off.

On June 1, 2024, at 2:56 PM, I interviewed the complainant, Roxana Garza (D.O.B. [REDACTED] 1991) at her residence on [REDACTED], Roma Starr County, Texas 78584. At approximately 2:00 AM, this morning, Jose had come over to her residence. They began arguing and Jose was getting physically aggressive. Roxana stated she had tried using her Apple Watch to contact law enforcement for assistance. She began yelling "Siri call 911!, Siri call 911!" At that point Jose grabbed and yanked off her watch from her wrist and threw it away to prevent her from contacting 911.

I observed that Roxana had purple bruising on her left wrist where she was wearing an Apple Watch.





On Saturday, June 01, 2024, I, Escobares Police Department Officer Ricardo Flores #334, began my investigation of a domestic disturbance that occurred in [REDACTED]

██████████, Roma, Texas 78584 that was referred to the Escobares Police Department by the Starr County Sheriff's Office (SCSO case number 2024-01396). I reviewed the body camera recording from Deputy Ryan Garcia #147 from when he responded to the call for service. In his investigation, Deputy Garcia was advised that Jose Francisco Perez Jr, a Commissioner for Starr County, had assaulted the complainant, Roxana Garza and her daughter. Roxana stated that Jose had grabbed her by the hair and pulled her into the residence.

On June 1, 2024, at approximately 2:10 PM, Jose Francisco Perez Jr (D.O.B. ██████████ 1974) came to the Escobares Police Department to speak with officers regarding the incident from this morning. The interview was recorded using a work phone and Jose was read his Miranda Rights, which he waived, signed the document saying so, and decided to speak to me. Jose admitted to grabbing Roxana by the hair when he "tried to put her to go inside" the residence.

On June 1, 2024, at 2:56 PM, I interviewed the complainant, Roxana Garza (D.O.B. ██████████ 1991) at her residence on ██████████ Roma Starr County, Texas 78584.

Roxana stated that she was drinking with her sister-in-law across the street from her home when her partner/boyfriend, Jose Francisco Perez Jr (D.O.B. ██████████ 1974), arrived and parked at her residence at ██████████. She met with Jose to see what he wanted. They argued outside and Jose became physical. At one point Jose pushed her causing her to fall by the porch area outside of her residence. After she thought the altercation ended, they walked their separate ways. She suddenly felt her hair being pulled by Jose and she was dragged/pulled into her own residence.

I reviewed the surveillance from "Camera 01" footage from ██████████. The time stamp was an hour ahead of the correct time but the date was from 06/01/2024. At the date and time stamp of 06-01-2024 at 03:10:58, Jose can be seen walking away from Roxana as she walks up the porch and towards the south end of the porch. Jose then walks back at a fast pace towards Roxana. Jose can then be seen grabbing Roxana from the hair and pulling/forcing her into the residence. Roxana appeared to be trying to pull back and away from Jose but was not successful.




