RESOLUTION CONCERNING SCHOOL SAFETY MEASURES

WHEREAS, the Board is authorized by Texas Education Code § 11.151(b) to act as a body corporate and to exercise the exclusive power and duty to govern and oversee the management of the public schools of the district, unless those powers have been specifically delegated by statute to the Texas Education Agency or to the State Board of Education; and,

WHEREAS, the Board directed by Texas Education Code § 11.1511(b)(1) to seek to establish working relationships with other public entities to make effective use of community resources and to serve the needs of public school students in the community; and,

WHEREAS, Pharr- San Juan-Alamo ISD has been advised by the Hidalgo County Health Authority that it should follow CDC guidelines with respect to the operations of its schools; and, act as a body corporate and to exercise the exclusive power and duty to govern and oversee the management of the public schools of the district, unless those powers have been specifically delegated by statute to the Texas Education Agency or to the State Board of Education.

WHEREAS, the Board is authorized by Texas Education Code § 37.102(a) to adopt rules for the safety and welfare of students, employees, and property and other rules it considers necessary to carry out the governance of the district; and,

WHEREAS, the Board is authorized by Texas Education Code § 37.105(a) to authorize a school administrator, school resource officer, or school district peace officer of a school district to refuse to allow a person to enter on or may eject a person from property for failing to follow District directives:

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Pharr-San Juan Alamo Independent School District that:

- 1. The recitals set forth above are found by the Board to be true and correct.
- 2. Pharr-San Juan Alamo ISD staff, students, parents and all visitors at Pharr-San Juan Alamo ISD facilities are henceforth required to wear protective facemasks, unless expressly excused from such requirement in writing for medical reasons a licensed physician.
