



TAKE 5 ALL STARS

MOBILE VIDEO TAPES d/b/a KRGV-TV5, and d/b/a KRGV-DT, its subsidiaries and affiliated companies (together, the “Company”), will conduct the Contest substantially as described in these rules, and by participating, each entrant agrees as follows:

1. **Description of Contest/Participation.** Three different High School cheer team picture will be posted on our Take 5 Instagram page.

2. **Dates of Contest:** The Contest will begin August 31, and for nine weeks.

3. **How to Enter:** Each week Take 5 will choose 3 different High School cheer team. The picture with the most likes after 24 hours will win!

4. **Winning the Contest:** The winner will be featured on our weekly show and will receive a surprise visit from one of our reporters. A spirit stick to honor their fantastic cheerleading efforts.

5. **Eligibility and Limitations.** Participants and winners must be U.S. residents at least 18 years old as determined by the Company, and must reside in Hidalgo, Cameron, Willacy or Starr County, Texas. Employees of the Company, the Contest’s participating sponsors and their advertising agencies, members of the immediate family of any such persons are not eligible to participate and win.
