



Fiesta de Palmas Beer Fest Instagram Contest

MOBILE VIDEO TAPES d/b/a KRGV-TV5, and d/b/a KRGV-DT, its subsidiaries and affiliated companies (together, the “Company”), will conduct the Contest substantially as described in these rules, and by participating, each entrant agrees as follows:

- Description of Contest/Participation.** Take 5 will give out 5 tickers to **Fiesta de Palmas** on the Take 5 Instagram page.
- Dates of Contest:** The Contest will begin on Saturday, October 12, 2024 at 8 am through Sunday October 13, 2024 at 8 am, winner will be chosen Monday, October 14, 2024.
 - NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING. Void where prohibited. Odds of winning depend upon the number of entrants.**
- How to Enter:** Follow Take 5 Instagram page, like contest post, tag 1 friend in comments section.
- Winning the Contest.** Winner will be chosen through a drawing by all eligible candidates who liked, tagged and shared post. Winner will be announced on October 14, 2023 through the Take 5 Instagram page. Winner must be 18 years or older and must show valid ID. Winner will be contacted by KRGV to claim prize.
- Eligibility and Limitations.** Participants and winners must be U.S. residents at least 18 years old (as of October 12, 2024) as determined by the Company, and must reside in Hidalgo, Cameron, Willacy or Starr County, Texas. Employees of the Company, the Contest’s participating sponsors and their advertising agencies, members of the immediate family of any such persons are not eligible to participate and win. The term “immediate family” includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as “in-laws,” or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.
