



### **Fiesta de Palmas Contest**

MOBILE VIDEO TAPES d/b/a KRGV-TV5, and d/b/a KRGV-DT, its subsidiaries and affiliated companies (together, the “Company”), will conduct the Contest substantially as described in these rules, and by participating, each entrant agrees as follows:

1. **Description of Contest/Participation.** Take 5 will give out 5 tickers each day starting October 14 to October 17<sup>th</sup> to **Fiesta de Palmas** on Take 5.

2. **Dates of Contest:** The Contest will begin on Monday, October 14, 2024 at 4 pm through Thursday October 17, 2024 at 8 am, winner will be chosen each day.

**A. NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING. Void where prohibited. Odds of winning depend upon the number of entrants.**

3. **How to Enter:** The first person to call with the correct code word wins.

4. **Winning the Contest.** Winner will be chosen through a drawing by all eligible candidates who liked, tagged and shared post. Winner will be announced each day on Take 5. Winner must be 18 years or older and must show valid ID. Winner will be contacted by KRGV to claim prize.

5. **Eligibility and Limitations.** Participants and winners must be U.S. residents at least 18 years old (as of October 14, 2024) as determined by the Company, and must reside in Hidalgo, Cameron, Willacy or Starr County, Texas. Employees of the Company, the Contest’s participating sponsors and their advertising agencies, members of the immediate family of any such persons are not eligible to participate and win. The term “immediate family” includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as “in-laws,” or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.

6. **Delivery Disclaimer.** The Company is not responsible for mechanical, technical, electronic, communications, telephone, computer, hardware or software errors, malfunctions or failures of any kind, include: failed, incomplete, garbled or delayed transmission of online entries, traffic congestion on telephone lines, the Internet or at any website or lost or unavailable network connections which may limit an online entrant’s ability to participate in the Contest, and any injury or damage to entrant’s or

any other person's computer related to or resulting from participating in or downloading any information necessary to participate in the Contest.

9. **Taxes.** Any valuation of the prize(s) stated above is based on available information provided to the Sponsor, and the value of any prize awarded to a winner may be reported to the IRS as required by law. Each winner is solely responsible for reporting and paying any and all applicable federal, state, and local taxes, related to prize acceptance and use not specified herein. Each winner must provide the Sponsor with valid identification and a valid taxpayer identification number or social security number before any prize will be awarded. Any person winning over \$600 in prizes from the Sponsor in a calendar year will be issued an IRS Form 1099 reporting the value of those prizes to the IRS.
